Personal and Instructor Development

Over the last five years, I have watched a Healing Touch Level 6 class for the second time, watched several Level 3 classes, completed the Training Class for the Advancement to Level 3 Instructorship, and viewed the Instructor videos. In addition, I am in good collegial contact with another teacher for HT in Germany who teaches in the Stuttgart area. We exchange regularly and coach each other.

Strengths: I can take good care of the participants in the classes, encourage them to rely on their own feelings and develop (further) confidence in their abilities. I often succeed in mirroring and raising awareness of blocking patterns. Through many practical examples, the courses become vivid. I am familiar with the physical background and explanatory models about the effectiveness of energy medicine.

My daily work as a naturopath and the continuous further education in holistic methods over the years led to a very well-founded knowledge and much practical experience in the healing work.

On the other hand, it is sometimes hard for me to adjust the explanations to a "beginner's consciousness" because of the many theoretical knowledge. Often, I have at least ten answers and backgrounds in my head immediately, so I have first to find the best possibility to explain things best for someone who has not this background knowledge at his disposal.

This means that I usually do not search for an explanation for questions, but rather which of the many explanations I have in mind is the most suitable. I get as feedback (from my husband) that my explanations are often too detailed and so I come "to the point" too late.

My plans for further growth include the completion of the mentor training as well as the search for suitable marketing opportunities and support to cause Healing Touch to be known in Germany.

In the future I would like to offer more often an attractive platform for exchange, community and growth with practice days.

A further challenge is the teaching assistant experience for the level 3 class in the next two years and the solo exam course.

I am constantly working on the topic of esteeming communication, which seems to me a very central topic, both in relationships and in conflicts.

Regularly I receive inquiries from my students about their treatments, which I answer by phone and also by e-mail. For many years I work in my own healing touch practice. I have experience as instructor in other holistic methods (foot reflexology).

My life has been associated with Healing Touch for many years, I developed many friendships with people who I have only met through HT, and I also can't imagine my life without the healing work as well as the teaching. Some challenges over the years have led me to expand my own boundaries and to look at my own patterns again and again.

I'd love to get more support and would like to work in a dedicated team. Unfortunately, only a few people in Germany have found the motivation to complete the training to the end and to certify themselves. Our fundament in healers should grow and we are in need of more teachers.

Overall summary of my experiences in self and professional growth

Over the past few years, I have devoted some attention to the subject of abundance or the lack of it. I am also looking for new ways to support clients and students in their abundance and their spiritual and personal growth.

I noticed how often people (also with regard to the costs of training or courses) were restricting themselves by their thinking. This is a big issue, too that influences the growth of Healing Touch in Germany and I do even sometimes see myself being part of it.

It is helpful for me to visit or listen to the regular practice group of Kurt Tepperwein, who is concerned with the power of the mind and the prosperity (prosperity in the sense that all areas are well) as well as the karatetraining.

In karate, I succeeded to pass the exam for 1st Dan. You can't practise Karate without being totally focused and in yours very midst, as in practising Healing Touch. This helps me to remain focused and be in my midst.

Taking exercises with Anthony Robbins in London I was able to run over glowing coals, which again showed the extreme power of our thoughts. The following days were full of topics as nutrition, health and solving of limiting beliefs. Among other things, I learned how quickly we can change our own condition and how deeply motion and emotion are connected.

The instructor videos gave possible and wonderful variations of teaching methods of Healing Touch, helpful suggestions to take more visual material into the classes and also nice impulses regarding the practice of the meditations. Since I have little opportunity to exchange experiences with different instructors in Germany, it was very nice to see so much of Cynthia's way of teaching and teaching the classes.
